Pupil Premium

Purpose

The Government believes that the Pupil Premium, which is additional to the main school funding, is the best way to address the current underlying inequalities between children eligible for free school meals (FSM) and their peers by ensuring that funding to tackle disadvantage reaches the pupils who need it most. It is for schools to decide how the Pupil Premium, allocated to schools per FSM pupil, is spent, since they are best placed to assess what additional provision should be made for the individual pupils within their responsibility.

Schools are free to spend the Pupil Premium as they see fit. However, they will be held accountable for how they have used the additional funding to support pupils from low income families. New measures are included in the performance tables that will capture the achievement of those deprived pupils covered by the Pupil Premium.

Key Facts

The Pupil Premium is allocated to children from low income families who are currently known to be eligible for FSM in both mainstream and non-mainstream settings and children who have been looked after continuously for more than six months.

The level of the premium in 2011-12 was £488 per pupil for pupils eligible for free school meals (FSM) and for pupils in care who have been continuously looked after for six months. It has increased to £600 per pupil in 2012-13 and has again been increased to £900 in 2013-14. This year the funding has increased to £1300 per pupil.

The Government has decided that eligibility for the Pupil Premium will be extended to pupils who have been eligible for FSM at any point in the last six years. As a group, children who have been eligible for FSM at any point in time have consistently lower educational attainment than those who have never been eligible for FSM.

Expenditure

The school has a dedicated underachievement identification and intervention strategy that focus' on all groups of pupils. We closely monitor each group of pupils as part of regular monitoring and take swift action to address all identified issues. FSM pupils have made significant progress.

Measuring the impact of Pupil Premium Grant Spending

Pupils are entitled to the pupil premium are tracked extensively throughout their time at school and usually make expected or better progress.

We also track other factors such as engagement in out of school hours learning and attendance on residential trips and visits to ensure that all pupils are accessing every opportunity equally.

The school reports progress of pupils entitled to the pupil premium to the governing body annually.

How do we know if this is making a difference? We track the progress of all our pupils in school on a termly basis and we compare children according to different characteristics including FSM. The DfE also publish our results in a report called RAISEonline which analyses our school data.

Below is a summary of the RAISEonline report for the children at the end of KS2 showing how well children who are entitled to FSM vs. those not entitled to FSM. These figures demonstrate that there is no significant difference in the attainment and progress of children who are entitled to FSM and those who are not. FSM children are achieving as well as non-FSM children.

We have included a summary of the Y1 phonics screening check, looking at how well FSM children did compared to non FSM children both in school and nationally.

There is also a summary of the RAISEonline report for the children at the end of KS2 showing how well children who are entitled to FSM vs. those not entitled to FSM. These figures demonstrate that there is no significant difference in the attainment and progress of children who are entitled to FSM and those who are not. FSM children are achieving as well as if not better than non-FSM children.
